## INSTRUCCIONES IMPORTANTES DE SEGURIDAD

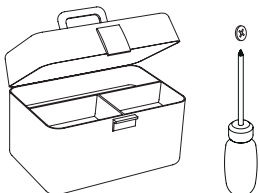
Esta luminaria portable utiliza una clavija polarizada (una de las terminales es más ancha que la otra) como característica para reducir el riesgo de descarga eléctrica. Esta clavija embonará en un único sentido dentro de un enchufe polarizado. Si la clavija no entra por completo en el enchufe, invierta el sentido de la clavija. Si no embona, contacte a un eléctrico calificado. Nunca utilice la lámpara con una extensión al menos que la clavija entre perfectamente. No altere la clavija.

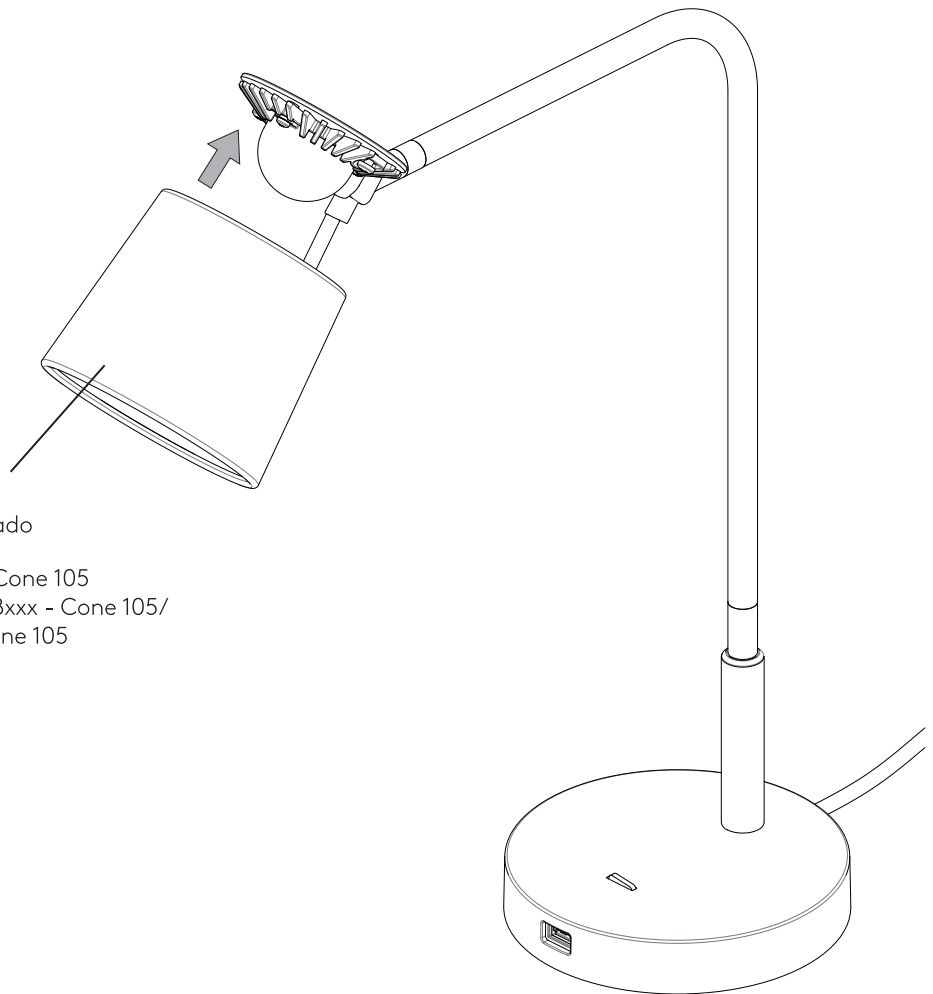
